What is Histiocytosis?

Histiocytosis is an umbrella term applied to a group of rare diseases, characterised by increased numbers of white blood cells called histiocytes in the blood and tissues. In all forms of histiocytosis, these cells, which are part of the protective immune system, begin to attack the body, targeting many organs of the body including the bone marrow, liver, spleen, lungs, skin, bone and brain.

The prognosis for patients varies greatly depending on the form of histiocytosis.

Gift Aid

Every gift you make to HistioUK - whatever its value - could be worth more at no extra cost to you just by choosing to Gift Aid it. Her Majesty's Revenue and Customs will add an extra 25p to every £1 you give to Histio UK.

How does Gift Aid work?

It is simple. As soon as you give your permission by completing a Gift Aid declaration form, we can claim the tax back on your donation. This means that a $\pounds 10$ donation will be worth $\pounds 12.50$ and for every $\pounds 50$ gift, we will actually receive $\pounds 62.50$.

Do I have to give regularly? No.

We can claim the tax back on a donation of any amount that has been made to us in the last four years. It doesn't matter whether you make a one off donation or set up a regular standing order or direct debit.

A single Gift Aid declaration will cover all future donations that you make to Histiocytosis UK i**f you are a UK tax payer.**

Am I eligible to make a Gift Aid donation?

If you are a UK tax payer, yes. Even if you are not employed, you are still eligible if you are paying tax on any of the following: Personal or occupational pension Stocks and shares Bank and building society savings accounts Rental income Overseas and UK investment dividends.

Charity Christmas Cards We have teamed with Charity Christmas Cards

How do Charity Christmas Cards Work?

First things first, the really great thing about Charity Christmas cards is that when you choose to donate, absolutely no extra cost will come from your pocket.

They take up to 50p directly out of the cost of producing each Christmas card. This means if you're buying 100 cards you can donate up to $\pounds 50$.

The other great thing about Charity Christmas cards is that while you are making a much needed donation Histio UK you are also helping to spread the awareness and the cause of the charity.

How much do THFY donate?

The donation THEY make to US on your behalf is 10p (including VAT) for every charity Christmas card purchased.

TerraCycle®.

There is a really simple way to convert your waste into money for charity. Here are step by step instructions.



What?

Take part in a recycling collection programme with TerraCycle®. Collect non-recyclable biscuit packaging that would normally be disposed of and sent to local landfill. The TerraCycle Brigade® recycling programme is a fun and easy way to reuse waste materials, whilst helping to raise money for Histio UK at the same time.

How? The waste packaging itself will be recycled into plastic products such as waste bins or watering cans, or 'upcycled' into new products such as pencil cases and lunch bags. This means that a smaller volume of raw materials then need to be extracted from the earth to produce the packaging for new products. TerraCycle will award a £0.02 donation for each biscuit packet collected and returned. Maybe you are a teacher or work in a large company and can setup simple drop off points in the staff room?

Packaging from most biscuit and non-savoury snack bars can be recycled under this scheme, including Penguins, Rich Tea and digestives as well as supermarket own brand packets from similar products.
