The **Histio Champion Awards** are operated by Histiocytosis UK (trading as Histio UK) a Charity registered in England and Wales no: 1158789 (referred to in these Terms as "we", "our", "us").

Please read these terms and conditions before nominating someone for an award.

What are the Awards for?

Histio UK's annual awards recognise outstanding contributions to support and awareness raised by individuals and groups who have used Histio UK. This year, we want to find and recognise the following amazing people:

More information about the Awards will be posted on our website as appropriate. As the Histio UK Awards are all about recognising amazing stories and inspiring others to support and raise awareness, there is no monetary or similar prize for any Award.

Who can be nominated for an Award?

You can nominate anyone for an Award if they have supported Histio UK between **1st May until midnight on 10th May**. It does not cost anything to nominate, and you can nominate as many people as you wish, including yourself! But please only nominate someone where you know they will be happy to be nominated and will not object to you providing their information to us.

What do I need to include in my nomination?

Nominations must be received by midnight on **10th May** and include your name address and email address so that we can get in touch with you if the person you have nominated is shortlisted. You also need to tell us the nominee's name, address and relationship to you and Histio UK and to explain (in up to 500 characters) why they should win an Award (we will consider them for all Awards that are relevant, based on what you tell us). It is always great to include a photo, but please only do this if you own the image and have the consent of the person(s) identified in the photograph. Nominations that are incomplete or exceed the stated word limit cannot be accepted.

We reserve the right to verify the validity of nominations and to disqualify you without notice if you tamper with the nomination process or do not comply with these terms and conditions. We do not accept any responsibility for loss of, or damage to, any nomination.

How will we decide who to shortlist?

All nominations received will be screened by our team. The shortlisting process is at our complete discretion. In general, we will be looking for outstanding examples of support and awareness that have clear objectives, creative and effective implementation and tangible, demonstrable results. We will also consider the structure, presentation and clarity of each nomination. We reserve the right to change and to alter the title and/or number of categories at any time.

How will my nomination or vote be used?

The information provided by nominators, nominees will only be used in connection with the Awards and for the purposes described in these Terms, including picking the shortlisted nominees and winners of the Awards and promotional activities. We will not share your data with anyone except as necessary in connection with the Awards (e.g. the Awards Ceremony venue) or otherwise permitted by these Terms. For further information on how we protect personal data, please read our Privacy Policy.

By making a nomination you understand and accept that your name, your nominee's name and the content of your nomination made me made public or used in the media, as may case studies of winners or shortlisted nominees. You are free to mark any information or sensitive parts of the nomination as 'Not for publication' and we will respect this.

If you submit a nomination in a category, we will keep in touch with you about progress with the Awards process. If you do not want to receive these updates, you will be able to opt out of receiving them.

A full list of Award winners will be made available shortly after International Histiocytosis Day. Our decisions are final and no other correspondence or discussion will be entered into regarding the selection of shortlisted nominations or winners.
